Subject: Routine Inspection No. 030-01902/89-001

On June 28, 1989, R. B. Provencher and John T. Jensen of this office conducted a routine safety inspection at the above address and at the Brockton, Massachusetts facility of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. In addition, our inspection examined the activities covered in your correspondence dated May 3, 1988. The findings of the inspection were discussed with you and Charles C. S. Ahn, Radiation Safety Officer at the conclusion of the inspection.

Based on the results of this inspection, it appears that your activities were not conducted in full compliance with NRC requirements. A Notice of Violation is enclosed as Appendix A and categorizes each violation by severity level in accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions," 10 CFR Part 2, Appendix C (Enforcement Policy). You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

In addition to the violations included in Appendix A, the inspectors observed other violations of NRC regulations and license requirements: a) the RSO failed to sign dose calibrator quality assurance check records (i.e., linearity test, accuracy test, etc.); b) labels on empty radioactive material packages were not completely obliterated prior to disposal; c) records of disposals of radioactive material held for decay did not contain the date of disposal. As indicated in the NRC Enforcement Policy, when deciding whether a Notice of Violation is needed, consideration can be given to violations of minor safety significance which are licensee identified and corrected or for which the licensee has planned prompt and effective corrective action during the inspection. After careful consideration of the criteria listed in the enforcement policy and your planned corrective actions for these violations, we have decided not to include these violations in the enclosed Notice of Violation. Similar violations of this type in the future may result in additional enforcement action.

During the inspection, the inspectors expressed concern regarding the apparent lack of oversight of the radiation safety program by the RSD as demonstrated by the number of violations identified. In addition, the RSD failed to determine the causes which led to the increased extremity exposure of a Nuclear Medicine technologist at the West Roxbury, Massachusetts facility, during 1988. The technologists' increased frequency of handling radioaccuse material and the use of a "non-conventional" syringe shield for 1 cubic continenter syringes apparently led to the relatively high monthly extremity exposures. In your response to this letter, please describe the actions you will take to assure that the RSD will provide appropriate oversight to the rediation safety program to prevent recurrence of these programatic deficiencies.

In accordance with Section 2.790 of the NRC's "Rules of Fractice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and your reply will be placed in the Public Document Room.




