The purpose of this modification is to provide incremental funding in the amount of \$20,511.00, which fully funds the contract. Accordingly, the contract is modified as follows:

Under Section B.2, Consideration and Obligation--Delivery Orders (MAR 1987), the first sentence in paragraph b. is deleted in its entirety and the following sentence is substituted in lieu thereof:

"b. The amount presently obligated with respect to this contract is \$77,511.00."

All other terms and conditions, including the contract ceiling amount of \$77,511.00, remain unchanged.
