Under the Freedom of Information Act, Public Laws 89-487, 90-23, 93-502, and 99-570, I wish to get access to or copies of the following documents which pertain to the history of this contract action:

For solicitations which began as an "Intent to Award against a GSA Schedule", I desire a copy of the CBD notice, responses to that notice, and the justification which the contracting officer prepared to support the decision to conduct the sole source acquisition.

For solicitations that are upgrades or additions to existing systems, I desire a copy of the original contract under which you acquired the equipment being upgraded herein. I also desire all subsequent contracts which also upgraded/added to that equipment or provided maintenance for same.

For solicitations which require a specific Delegation of Procurement Authority (DPA), I desire a copy of the Agency Procurement Request (APR) or agency equivalent, and resultant DPA.

For solicitations for which the agency claims an exemption from the DPA requirement, I desire a copy of the documents which supports that claim. When the agency does not submit APR's and DPAs, please provide the agency equivalent forms that authorize procurement actions.

For solicitations that are new requirements, I desire all agency-decisive documents associated with the final decision to procure the equipment/services.

For the contracts identified above, I require only the SF33 (cover sheet) from the contract and all delivery orders issued against the contract. I do not require the other sections of those solicitations or contracts.

It is my desire to have you (1) provide exact copies of the requested documents - including authors, signatures and dates - with the understanding that I will pay reasonable reproduction and search costs; or (2), if appropriate and timely, make the records available for inspection in accordance with the provisions of the Act.

If fees are associated with the requested documents, I request a waiver of these fees in that the documents requested "contribute to public understanding of the operations and activities of the Government", are not publicly available from another source, and do not primarily benefit the requestor's commercial interest, nor injure the competitive position of the parties involved, but rather further the interest of increased competition in Federal procurements.

If fees are associated with my request and you choose not to waive these fees, please accept this letter as authorization to proceed with the search and reproduction as long as the charges do not exceed \$50. If the fees do exceed \$50, please contact me for authorization of payment.

If for any reason you believe that some portions of these files are exempt from disclosure under the Freedom of Information Act, please delete any such alleged exempt material. However, my consent is designed to facilitate your prompt response and in no way waives my right to the complete documents which I may still choose to request.

I look forward to hearing from you within the next ten (10) working days, pursuant to Section 552 (a) (6) (i) of the Freedom of Information Act. In the event I am denied any portion of these documents, please specify the statutory basis for the denial, the nature of the information denied, and the names and titles of the persons responsible.
