The SONGS monitoring report covering the month of September is submitted in accordance with the requirements of CRWQCB Order 88-001 (NPDES Permit No. CA0001228). A summary of the generating unit's status and significant analytical results is provided below.

The unit was operational during September. All sampled water sources were found to be within permit limits, except the Mesa Sewage Treatment Plant effluent which was high on settleable solids September first due to hydraulic overload. This was due to the unanticipated early shutdown of one of the units for refueling and the associated influx of contractors awaiting badge processing. The situation was solved by starting up train "B" and increasing the amount of treatment plant in use.

Pursuant to Order No. 88-001, Reporting Requirement 12, the following representative is authorized to sign and certify all reports required by this order: Arthur Kneisel, Environmental Engineer.
