The available information concerning a proposal by the applicant to modify the material surveillance program to increase the number of capsules to include vessel material from Davis-Besse Unit No. 1, Rancho Seco, and Arkansas Unit No. 1 has been reviewed by the Materials Integrity Section, Materials Engineering Branch, Office of Nuclear Reactor Regulation. A supplement to our sections of the Safety Evaluation Report is enclosed as Attachment 1 addressing only the Davis-Besse Unit No. 1 material capsules.

The applicant has not finalized a decision to implement the proposed integrated surveillance program nor has he provided documentation of the technical basis. We will require the information contained in Attachment 2 to complete our evaluation of the proposed surveillance program for Davis-Besse Unit No. 1.
