SUBJECT: RESOLUTION OF OPEN ITEMS REMAINING ON THE DAVIS-BESSE, UNIT 1 SAFETY EVALUATION REPORT (REF. MEMORANDUM FROM L. ENGLE TO C.F. MILLER, DATED OCTOBER 5, 1976)

In response to your memo (referenced above), the Davis-Besse SEP update which you requested for October 15, 1976 can not be met. Due to our work load, we anticipate completion of our review of Amendments 33 through 38 by December 15, 1976. During the course of our review, we have had several drawing review meetings with the applicants in order to resolve our concerns. Refer to our meeting summary memoranda on:

- 1. Drawing review of the Auxiliary Feedwater, Main Steam Line Isolation, and Feedwater Line Rupture Control System (memo from A. J. Szukiewicz to T. A. Ippolito dated 5/6/76), and
2. Drawing review of Reactor Protection System (RPS) and the Engineered Safety Features Actuation System (ESFAS) (memo from A. J. Szukiewicz to T. A. Ippolito dated 7/29/76).

In addition, a second site visit was conducted and completed on October 6, 7, and 8, 1976. A draft copy of the minutes was forwarded to you for information (final copy will be issued by November 4, 1976). This memo identified concerns expressed by the staff during the site visit. It should be pointed out that we require the applicant not only to address the concerns addressed in the SEP (dated June 23, 1975) and the SEP update (dated June 17, 1976), but also the concerns expressed in the above referenced memos in order for us to complete our review.

In order to expedite our review efforts and to support the applicant's claim that most of the concerns as expressed by the staff, have been addressed in the FSAR Amendments 33 through 38, we request that the applicant provide an auditable cross reference that identifies the

The updated SER (scheduled for December 15) will reflect the current status of the Davis-Besse applicant and identify the remaining outstanding concerns (if any).
