MEMORANDUM AND ORDER

On April 30, 1973, a "Notice of Receipt of Application for Facility Operating License, Notice of Consideration of Issuance of Facility Operating License and Notice of Opportunity for Hearing" was published in the Federal Register (38 Fed. Reg. 10661). Pursuant to said notice, two petitions to intervene, and a request for extension of time within which to file a petition, were submitted. In a Memorandum and Order dated August 13, 1973, the Board granted the petition of the Coalition for Safe Electric Power, denied the second petition and denied the request for more time.


Subsequently, by letter dated October 11, 1973, the said Coalition for Safe Electric Power now seeks to withdraw from this proceeding. The Board will consider said letter as a motion to withdraw. Since there is no other matter in controversy between the parties, and since the Board sees no reason to continue the proceeding, it would appear that this proceed-

ing should be terminated. Such action is consistent with the provisions of 10 CFR 2.104, 2.105, 50.58(b) and 10 CFR Part 50, Appendix D.

Accordingly, unless, on or before October 28, 1973, good cause is shown to the contrary, this proceeding will be dismissed.
