SUBJECT: MARCH 30, 1977, MEETING WITH FLORIDA POWER CORPORATION

The NRC staff (J. Angelo, J. Helton, J. Gilroy, J. Conway, and E. Nelson) met with FPC personnel (J. Sadgers and S. DeBels) to discuss the completed QA program description for the operations of Crystal River #3.

FPC responded (March 3, 1977, letter) to the staff's January 25, 1977, letter which requested a commitment to comply with ANSI N18.7 and the Regulatory Guides which endorse the daughter standards contained therein. Each supportive note in FPC's letter was discussed in detail, and the resolution of each note is as follows:

No. 1 - OK - As written.

No. 2 - OK - FPC will add a statement showing compliance with the Regulatory Guides which endorse the ANSI Standards referenced in N18.7 (see Enclosure 1).

No. 3 - OK - FPC will show the Nuclear General Review Committee (referenced therein) in Figure 1-22.

No. 4 - OK - As written.

No. 5 - OK - As written.

No. 6 - FPC clarified the meaning of "amended" and subsequently will add the paragraph (referenced therein) to Section 1.7.6.3.9 of the PSAR.

No. 7 - OK - As written.

No. 8 - Part 1 - OK as written.

Part 2 - Not acceptable. FPC will evaluate their recommendation to delete subparagraphs 1.7.6.7.1.g.2 and 1.7.6.7.1.g.3.

No. 9 - OK - With the exception of Item "1", which is not acceptable.

No. 10 - OK - As written

No. 11 - Part A - OK as written

Part B - Not acceptable. FPC will evaluate their recommendation to delete the subparagraphs C.7 through C.12 in Section 1.7.8.7, 1.c.

No. 12 - OK - with the following exceptions:

Item "1" - "Contractors" must be qualified to AWSI N45.2.6.

Item "2" - Statement should be deleted.

Item "3" - Requires additional clarification for staff's assessment.

FPC will inform the staff within 30 days of their responses to satisfy the open items discussed above prior to incorporating them into an amendment to the Crystal River #3 FSAR.
