SUMMARY OF MEETING CONCERNING THE CRYSTAL RIVER, UNIT 3 EMERGENCY AND INDUSTRIAL PLANS

On February 18, 1976, representatives from the Florida Power Corporation (FPC), the State of Florida, and the NRC staff met in Bethesda, Maryland to discuss the Emergency Plan (EP) and Industrial Security Plan (ISP) for Crystal River, Unit 3 (CR-3). An attendance list is attached.

Emergency Planning

The FPC was requested to meet with the staff to discuss the CR-3 EP documented in Amendment No. 47 to the PSAR. A Florida state official was present, at the request of FPC, to clarify emergency notification procedures.

The representative from Florida presented a copy of the revised state plan (dated May 1975) which indicated that the previously used alpha/numeric classification system for emergencies was no longer in use. The revised state plan resolved the staff's concerns for emergency notification plans between FPC and state and local interfaces. The staff requested the state of Florida to clearly note "TO INSTEAD OF FROM" on the wind direction line in the emergency message form.

The FPC stated that the availability and capability of local volunteer fire units was very limited. FPC stated that the local volunteer fire companies had expressed an unwillingness to respond to a call for assistance from FPC. For this reason, the CR-3 EP places no reliance on the local fire departments for fire support. Therefore, plant personnel are trained in the use of all fire fighting equipment. (ISE-Reg 2 states that plant personnel fire training has been found satisfactory.)

FPC described its proposed revision to the ISP. The staff indicated that staff positions would be forwarded to FPC after docketing of the proposed Revision No. 2 of the CR-3 ISP.
