- 1. All correspondence, memoranda, reports, records, studies, bills, drafts of bills, surveys, comments relating to Michigan Constitution, Article VII, §24 since 1964.
- 2. All correspondence, memorands, reports, studies, bills, drafts of bills, surveys, or comments relating to any attempts by Consumers Power or any other utility in support, opposition or relation to any proposal to amend, legislate pursuant to, defeat or affect Article VII, §24 since 1964.
- 3. All correspondence, memoranda, reports, studies, bills, drafts of bills, surveys, or comments relating to, or proposal relating to any attempt to define, limit or expand the amount of electricity which any municipal system may lawfully sell outside the City, Town, Village jurisdictional boundaries.
- 4. All correspondence, memoranda, or records of any kind concerning voluntary payments of over \$100 by Arthur Land or Consumers Power Company or any Company official or employee to state executive or legislative officials since January 1, 1964 of over \$50 to any political or citizens committee of any kind, but excluding tax payments, fees, or any similar payment imposed by law.
