On September 20, 1977, members of the NRC staff met in Bethesda, Maryland with representatives of Consumers Power Company (CPC) and Bechtel Associates. An attendance list is attached.

CPC discussed physical security plans for the Midland site during latter stages of construction of Unit 1 while Unit 2 is operational. This portion of the Security Plan will be submitted for staff review by December 1977. Details of the discussion and plan relate to information deemed under 10 CFR 2.790d to be exempt from public disclosure.

The staff stated that the Midland Security Plan must follow draft NUREG-0207, "Interim Format and Content for a Physical Security Plan for Nuclear Power Plants," dated February 1977. NUREG-0207 will be reviewed before the end of 1977 to eliminate the draft status.
