

## Gentlemer:

This refers to the inspection conducted by Mr. R. E. Oller of this office on August 27-28, 1974, of activities at the Babcock & Wilcox Company, Socated in Mt. Vernon, Indiana, relative to the manufacture of the reactor pressure vessels for the Midland Units 1 and 2 authorized by ACE Licenses No. CPPR-81 and No. CPPR-82 and to the discussion of our findings with Mr. Slager of your staff and representatives of the Babcock & Wilcox Company at the conclusion of the inspection.

A copy of our report of this inspection is enclosed and identifies the areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, interviews with personnel, and observations by the inspector.

No violations of AEC requirements were identified within the scope of this inspection.
