### Gentlemen:

This refers to the inspection conducted by Messrs. Erb, Vandel and Yin of this office on December 11-13, 1974, of activities at the Midland Plant construction site authorized by AEC Construction Permits No. CPPR-81 and No. CPPR-82 and to the discussion of our findings with Messrs. Kessler, Keeley, others of your staff and representatives of the Bechtel Corporation at the conclusion of the inspection.

A copy of our report of this inspection is enclosed and identifies the areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors.

A violation identified through your internal audit program and which was reported in a timely manner and where adequate corrective action was initiated, is set out in the inspection report. No additional information is needed for this item at this time.

In accordance with Section 2.790 of the AEC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the AEC's Public Document Room. If this report contains any information that you or your contractors believe to be proprietary, it is necessary that you make a written application to this office, within twenty days of your receipt of this letter, to withhold such information from public disclosure. Any such application must include a full statement of the reasons for which it is claimed that the information is proprietary, and should be prepared so the proprietary information identified in the application is contained in a separate part of the document.
