Cooke, and Slager and others of your staff at the conclusion of the inspection. A copy of our report of this inspection is enclosed and identifies the areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, interviews with plant personnel, and observations by the inspector. During this inspection, it was found that certain of your activities appear to be in noncompliance with NRC requirements. The items and reference to the pertinent requirements are listed under Enforcement Action in the Summary of Findings section of the enclosed inspection report. This notice is sent to you pursuant to the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Section 2.201 requires you to submit to this office within thirty days of your receipt of this notice, a written statement or explanation in reply, including: (1) corrective steps which have been taken by you, and the results achieved; (2) corrective steps which will be taken to avoid further items of noncompliance, and (3) the date when full compliance will be achieved. Such a statement or explanation should be provided for each of the items listed. 8006250 388
