

REQUEST FOR ACTION UNDER 10 CFR 2.206

Notice is hereby given that by petition dated April 1, 1980, the Concerned Citizens for the Charlevoix Area requested that the Big Rock Point Nuclear Plant be shut down immediately because, they contend, the plant does not meet containment integrity requirements. This petition is being treated as a request for action under 10 CFR 2.206 of the Commission's regulations, and accordingly action will be taken on the petition within a reasonable time.

THE UNSHIELDED STEEL CONTAINMENT AT THE BIG ROCK NUCLEAR POWER PLANT IS INSUFFICIENT TO CONTAIN RADIATION THIS IS INDIRECT VIOLATION OF NUREG 0578 REQUIREMENT 2.213 STATING THAT NUCLEAR POWER PLANTS MUST SHUT DOWN IMMEDIATELY IN THE EVENT OF COMPLETE LOSS OF A SAFETY FUNCTION (A REQUIREMENT OF TMI CRITERIA), WE ARE NOT PROTECTED OUR LIVES ARE IN IMMEDIATE DANGER. SEE REFERENCE IN CONSUMER'S POWER LETTER TO NRC OCTOBER 30, 1979 DECEMBER 27, 1979, MARCH 14, 1980. THE NRC ORDER FROM SEPTEMBER 13, 1979 ORDERS ALL NUCLEAR FACILITIES TO COMPLY WITH TMI REGULATIONS. BIG ROCK DOES NOT MEET MINIMAL NRC REQUIREMENTS RELATING TO CONTAINMENT INTEGRITY. THE PLANT MUST BE SHUT DOWN IMMEDIATELY UNTIL SUCH TIME NRC MINIMUM REQUIREMENTS ARE MET. THE PEOPLE IN CHARLEVOIX SHOULD NOT BE SUBJECTED TO THIS INJUSTICE. RESPOND IMMEDIATELY
