### ENFORCEMENT CONFERENCE SUMMARY

SUBJECT: ENFORCEMENT CONFERENCE TO DISCUSS NRC FINDINGS

On January 26, 1990, the owner of B&H Wireline Services met with NRC staff in the Region IV office to discuss apparent violations of NRC requirements observed during an inspection conducted at the licensee's facility. The discussion included review of those corrective actions proposed or taken by the licensee as a result of the inspection.

The staff presentation focused on the apparent lack of management oversight of the radiation safety program during this inspection period. The staff reviewed their concerns regarding the number of apparent violations identified. Additionally, they reviewed their concern regarding failure to maintain adequate control over a number of documents related to the program and failure to exercise authority as radiation safety officer under this license.

The owner summarized those corrective actions which had been implemented since the date of the inspection. These included efforts to obtain duplicates of some of those records missing during the inspection, the purchase and calibration of survey instruments, and retraining of personnel. He also confirmed that he had moved his sealed sources to the storage location authorized by the license and had submitted an amendment request to store material at another location where he is currently doing business.

The owner also questioned one of the apparent violations documented in the inspection report. This apparent violation related to the licensee's failure to have obtained written agreements with well owners or operators prior to performing a logging job using sealed sources. The owner stated that he had reviewed those agreements in his possession at the time of the inspection, as well as others that he had located subsequent to the inspection, and believes that he had obtained a signed agreement from each production company that had employed his services. He further stated that he had reviewed these with individuals working under the license and that they agreed that all required agreements had been obtained. He indicated that he would forward copies of these documents for NRC staff to review. The NRC staff confirmed that they would review the subject documents and withdraw this violation if appropriate.

The staff explained that when a decision regarding enforcement action was reached the licensee would be subsequently notified.
