By letter dated October 5, 1071 to Mr. Cherry and October 6, 1971 to Mr. Like, I informed you of the impending filing of five Pabcock and Wilcox Company proprietary topical reports regarding its emergency core cooling system. B&W on October 6, 8 and 11, respectively, filed proprietary topical reports BAW-10030, BAW-10031 and BAW-10033. Because material previously described as being included in a report numbered BAW-10032 is not necessary nor being used in the present analysis of the emergency core cooling system, no such report has been filed. I enclose herewith a copy of BAW-10034 which contains multinode analysis of BAW 2568 MWt nuclear plants during loss of coolant accident.
