Subject: GE-NEBG Organizational Changes

In Licensing Topical Report NEDO-11209-04A, Revision 1, the General Electric Company has committed to notify the NRC of organizational changes affecting the BWR Quality Assurance Program within thirty days after implementation. In compliance with this commitment, notification of organizational changes effective July 15 and August 1, 1980, as documented on the attached draft organization chart, "Figure 1-6, Nuclear Products Division" (page 1-18 of NEDO-11209-04A, Revision 1), is transmitted.

Effective July 15, 1980, the Nuclear Engineered Equipment Procurement Operation was renamed the Nuclear Energy Purchasing Operation and was transferred from the Nuclear Engineering Division to the Nuclear Products Division, reporting to the Vice President & General Manager of the Nuclear Products Division. All functions and responsibilities formerly assigned to the Nuclear Engineered Equipment Procurement Operation were transferred with this organizational change.

Effective August 1, 1980, the Direct and Indirect Material Purchasing and the Fuel Cycle Procurement functions, formerly assigned to the Materials Operation of the Wilmington Manufacturing Department, were transferred to the Nuclear Energy Purchasing Operation in the Nuclear Products Division. Concurrently, the purchasing function for the Nuclear Control & Instrumentation Department (NC&ID) was renamed Control & Instrumentation Purchasing and was transferred from the NC&ID Materials function to the Nuclear Energy Purchasing Operation in the Nuclear Products Division. These organizational changes transfer the product-related purchasing functions from the Wilmington
