

Dear Mr. Lieberman:

We are in receipt of your letter of April 21, 1980, assuring us that the "Stoff will continue to serve Decade with all papers filed by the Staff \* \* \*."

Your letter was received at the same time as the Staff failed to serve us with its Modification of November 30, 1979 Order, which we only received after calling to complain that we had not been served. We did not receive the Order, of course, until it was too late to request a hearing that must be done within 20 days of issuance of the order. This experience mirrors the occurrence involving the Staff's earlier Order Modifying Confirmatory Order of November 30, 1979, which was also not served on us until after we called to complain and after the time for requesting a hearing had expired.

Enclosed for your information is a copy of a motion we have filed seeking to extend the time to request a hearing necessitated by the Staff's persistent refusal to serve us.

Given this experience, we do not share your confidence that the service problem has been cured.
