Dear Mr. Kerr,

All of the 1980 utility site plans have now been submitted for review. As you know, Florida Statutes require utilities to annually submit a Ten-Year Site Plan (TYSP) to the Department of Community Affairs. The plan is to include an estimate of the utility's power generating needs and is to disclose the general location of proposed power plant sites.

DCA considers the TYSPs as planning documents and is required to review:

- The need, including the need as determined by the Public Service Commission, for electrical power in the area to be served.
- The anticipated environmental impact of each proposed electrical power plant site.
- Possible alternatives to the proposed plan.
- The views of appropriate local, state, and federal agencies, including the views of the appropriate water management district as to the availability of water and its recommendation as to the use by the proposed plant of saltwater or freshwater for cooling purposes.
- The extent to which the plan is consistent with the state comprehensive plan.
- The plan with respect to the information of the state on energy availability.



State law recognizes the plans are based on tentative information submitted by a utility in order to receive advisory comments or assistance in planning efforts and in the selection of power plant sites. TYSPs in no way constitute a permit application for construction or operation of any power plant.

The DCA composite reviews of the 1977, 1978 and 1979 plans are being drafted, and we will send copies to you as soon as they are published. We have enclosed a copy of the draft Introduction to the 1979 reviews, which discusses the scope and responsibilities of the Power Plant Siting Program and the problems which must be resolved. Also enclosed are copies of the 1980 TYSPs for your review.

Please submit your written comments to the Power Plant Siting Program August 15, 1980. Thank you for your cooperation.
