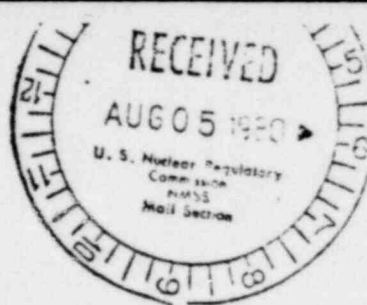


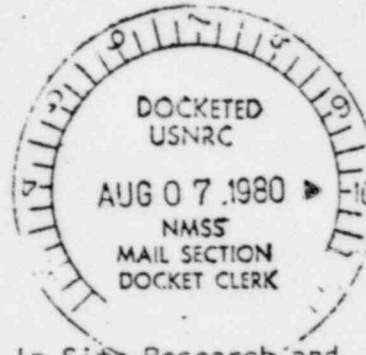

Re: Nine Mile Lake In Situ Research and
Development License Application; TFN 15/186

Enclosed are four copies of Appendix D to accompany Rocky Mountain Energy Company's (RMEC) Nine Mile Lake in situ R & D License Application of May 27, 1980. Two copies are also being sent to Mr. Dennis Morrow of District IV for inclusion in the applications on file with that office. The Appendix and appurtenant drawings as well as a revised Table of Contents have been three-hole punched for ready inclusion in the May application.

Also included with this package is a new Appendix C which is an accurate metes and bounds legal description of the proposed license area. This should replace the legal subdivision description originally supplied in the application.

As required by item 11 of form 5, proof of notice and mailing to all persons within one-half mile of the proposed license area is also included with this letter.

This letter will also serve to correct two errors which were contained in the text of the original application submittal. Page M-8, paragraph 1, line 11 should read:

" . . . geologic sequence. Pages M-23 to M-24 present . . . site geology."

Page M-24, paragraph 3, line 1 should read:

"Appendix D-7 (Ground water) . . . of 1978."
