USS HECTOR (AR-7) INSTRUCTION 9090.1 CHANGE TRANSMITTAL 1

Subj: Quality Assurance Program for the Packaging of Radioactive Material for transport and transportation of Radioactive Material under certain conditions (10CFR71)

1. Purpose. To transmit change 1 to the basic instruction.

2. Action.

a. Make the following pen and ink changes:

(1) On page iv, "DEFINITIONS", after "RSO", add "ARSO - Assistant Radiographic Safety Officer (the Senior Radiographic qualified Petty Officer within the licensed activity)."

(2) On page I-1, change paragraph 1.2 "D" to 1.2 "E". Add new paragraph 1.2 D, as follows: Assistant Radiographic Safety Officer (ARSO). The Assistant Radiographic Safety Officer assists the RSO in carrying out his duties and, in his absence, acts in his place.

(3) On page A-I-1, under "Radiographic Safety Officer", add "Assistant Radiographic Safety Officer."

(4) On page II-1, under "2.1 Purpose", delete existing paragraph and add "As the final responsibility for the QA Program requirements (as specified in reference (b)) rests with the USS HECTOR, this section specifies the necessary action which must be undertaken to successfully establish and execute a viable quality assurance program for packaging licensed materials."

(5) On page II-1, under "2.3.D", change to read "Prior to use, all defined quality control procedures, engineering procedures and specific provisions of the package design approval shall be satisfied. Additionally, the QA Program will emphasize control of critical safety characteristics for any shipping packages used in conjunction with licensed material."

(6) On page IV-1, under 4.3.A., line 3, change to read "He shall ensure, for each shipping container, that the ARSO performs the following operations:."

(7) On page V-1, under 5.3.A., line 4, change to read "He shall ensure, for each shipping container, that the ARSO performs the following operations:."

(8) On page VII-1, under 7.2.A., change to read "Established schedules of audits of the RMPQA Program will be performed. Each activity will be audited at least once a year. Auditors shall have no day-to-day responsibility in the activity being audited. Results of all audits will be reported to the Commanding Officer, with copies to the Repair Officer and Radiographic Safety Officer. Audit reports will be evaluated and deficient areas corrected. The audits being performed will be dependent on the safety significance of the activity being audited. Audit reports will be maintained as part of the Quality Control records." Delete paragraph 7.2.B.


