Letter of Confirmation


Dear Dr. Hendrie :

Concerning written assurance that "No material including equipment and devices, will be retransferred without prior agreement with the United States for U.S. supplied material including equipment and devices," the Government of the Republic of Korea wishes to provide such assurance on a generic basis.

This will confirm that the Government of the Republic of Korea assures the Nuclear Regulatory Commission that measures included in the Agreement for Cooperation between the Government of the Republic of Korea and the Government of the United States concerning Civil Uses of Atomic Energy which entered into force on March 19, 1973 and was amended on June 26, 1974 will be maintained with respect to all nuclear materials including equipment and devices imported from the United States.

We intend that the measures of the Agreement will cover pending applications and all future imports of nuclear material, including equipment and devices.
