

The purpose of this modification is to extend the period of performance at no additional cost to the Government to accommodate the completion of Optional Service No. 3, "Acquisitions Subsystem". Accordingly, the contract is modified as follows:

"F.3 Duration of Contract Period

The performance of work described herein shall commence on February 1, 1986 and shall expire on March 31, 1989 with the exception of Task Orders 2 and 3

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
