Gentlemen:

This acknowledges the receipt of your letter, dated June 10, 1988, by which you transmitted Revision 6 to the Trojan Nuclear Plant Security Force Training and Qualification Plan (PGE 1024), dated April 1988. We have determined that portions of these plan changes are consistent with the provisions of 10 CFR 50.54(p) and are therefore acceptable. However, as indicated in the enclosure, certain other portions decrease plan effectiveness and are therefore inconsistent with the provisions of 10 CFR 50.54(p). Accordingly, you are to follow your previously approved plan in regard to these items. Resubmit corrected plan pages as necessary to maintain plan continuity.

Elements of Revision 6 in the enclosure hereto, which were found unacceptable, were discussed with representatives of the Security Department on November 8 and 9, 1989.


