The purpose of this modification is to change the contract number and obligate funds in the amount of \$281,613.00, which fully funds the contract. Therefore, the contract is modified as follows:

. . .

- The Contract No. is revised from "NRC-39-90-190" to "NRC-33-90-190" on Standard Form 36 entitled "AWARD/CONTRACT", block no. 2 and wherever it appears in the contract.
- Subsection B.3 entitled "CONSIDERATION AND OBLIGATION--DELIVERY ORDERS," paragraph b., the obligated amount is increased from \$100,000.00 by \$281,613.00 to \$381,613.00. Therefore, the first sentence under paragraph b. is revised to read as follows:

"The amount presently obligated with respect to this contract is \$381,613.00."

All other terms and conditions remain unchanged, including the contract ceiling amount of \$381,613.00.
