SUBJECT: CRGR MEETING NO. 174

The Committee to Review Generic Requirements (CRGR) will meet in the afternoon on Wednesday, November 29, 1989, in Room 4B-11, OWFN. The agenda is as follows:

- 1:00-2:30 p.m. The Committee will continue their review (begun at Meeting No. 169) of the proposed final Access Authorization rule. (A revised review package, reflecting CRGR comments at Meeting No. 169, will be provided to CRGR members when received.)
- 2:30-5:00 p.m. The Committee will complete their discussion (begun at Meeting No. 172) of the NUBARG backfit appeal of the staff's position prohibiting use of nuclear and requiring solid water pressurization for hydrotesting of BWRs. (An information package will be provided to CRGR members by CRGR staff by COB, November 22, 1989.)

If a CRGR member cannot attend the meeting, it is his responsibility to assure that an alternate, who is approved by the CRGR Chairman, attends the meeting.

Persons making presentations to the CRGR are responsible for (1) assuring that the information required for CRGR review is provided to the Committee (CRGR Charter - IV.B), (2) coordinating and presenting views of other offices, (3) as appropriate, assuring that other offices are represented during the presentation, and (4) assuring that agenda modifications are coordinated with the CRGR contact (J. Conran X29855) and others involved with the presentation. Division Directors or higher management should attend meetings addressing agenda items under their purview.
