## MEMORANDUM AND ORDER

The Board, in reviewing the SFES and the Kerr-McGee Engineering Report, finds a perplexing contrast. The staff analysis is based on the estimated or guessed values for the distribution coefficients for a number of chemical species. These values are used to calculate the retardation factors and directly affect the source term. In contrast, the Engineering Report analysis is based on direct measurements of the concentrations of chemical species in leachate tests.

The leachate test results appear to be significantly different than the staff assumed distribution coefficients. For example, in the case of lead, the difference is approximately 30 fold. The Board requests staff to testify

at the upcoming hearing as to why the Kerr-McGee test results are not pertinent to staff's analysis or, to the contrary, how staff results would be changed by using the Kerr-McGee observational data.

The Board does not understand the SFES forecasts of cyanide contamination of the ground water, in terms of the confidence that can be placed in the analysis. We ask staff and Kerr-McGee to testify on this issue at the upcoming hearing.

It is so ORDERED.
