SUBJECT: NRC INSPECTION REPORT NO. 50-261/89-24

This refers to the Nuclear Regulatory Commission (NRC) inspection conducted by W. J. Tobin on October 16-20. The inspection included a review of activities authorized for your H. B. Robinson facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed Inspection Report.
