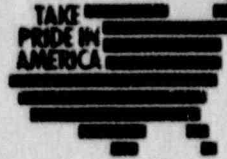




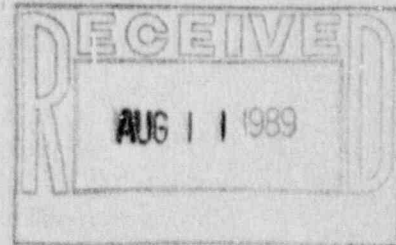

Dear Ms. Gruszynski:

As discussed in your July 25, 1989, telephone conversation with Dan Jewell of the Regional Division of Environmental Affairs, we no longer have a need to maintain the subject materials license. Our last Campbell Pacific (CPN) Model 500 moisture/density probe (Serial No. H36071716) was shipped to the manufacturer (CPN, 2830 Howe Road, Martinez, California) on or about April 21, 1989, for disposal (copy of receiving report enclosed). CPN is licensed by the State of California, Department of Health Services (materials license No. 1100-07). A leak test was conducted on the probe prior to shipment in accordance with regulations (copy of test results enclosed).

We are requesting that our license be terminated for the following reasons: (1) We no longer have any source materials in our possession, (2) we have no projected need for such materials, and, (3) our materials license does not expire until October 1992.
