This letter refers to an unannounced, routine security inspection of your activities at Rancho Seco Nuclear Generating Station as authorized under NRC license No. DPR-54. The inspection was conducted by L. Norderhaug of this office on November 6 - 24, 1989. This letter refers also to the discussion of the preliminary inspection findings held by the inspector with L. Houghtby and other members of your staff on November 8, 1989, and subsequent conversations with members of the security organization on November 28, 1989.

Areas examined during this inspection included activities related to physical protection as described in the enclosed inspection report. Within those areas, the inspection consisted of selective examination of procedures and representative records, interviews with facility and contract personnel, and observations by the inspector.

Within the scope of the inspection, no violations were observed.

In accordance with Section 2.790(d) of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, documentation of the findings of your safeguards and security procedures are exempt from public disclosure; therefore the enclosed inspection report will not be placed in the Public Document Room and will receive limited distribution.
