

A recent review of our Fundamental Nuclear Material Control (FNMC) Plan, prompted by the recent reduction in quantity of Strategic Special Nuclear Material in Plant I (HTGR Fuel Manufacturing), revealed a need to revise certain sections of the FNMC plan.

The changes in this revision were made pursuant to 10 CFR 70.32(c). Typical type changes are stated below:

Section 2

- Quality Control Laboratory was removed from Plant I and added to Plant V.
- Physical Boundaries was redefined for Plant IV.
- Figure 2.1.1-1 was revised to show current control areas in Sorrento Valley.
- Figure 2.1.1-2 was revised to show the current site boundary.

Section 3

- Table 3.7-1: "Note" at the bottom of page 5 of 5 was revised for clarification.
- Table 3.7-2 required corrections to calculations.
