Dear Mr. Grimsley:

Pursuant to the Freedom of Information Act, 5 U.S.C. §552, and 10 C.F.R. §9.1 et seq., the Massachusetts Attorney General's Office ("MAG") requests that you produce to MAG the following documents, including, but not limited to, records as defined in 10 C.F.R. §9.13 ("Documents"), concerning the September 27, 1989 onsite exercise ("the Exercise") of the Seabrook Nuclear Power Plant. All requested documents within the possession or control of NRC, or its agents or contractors, should be produced, whether generated by NRC, Applicants, their agents or contractors, or otherwise.

1. All instructions, documents, evaluation criteria, and information concerning the Exercise given to federal evaluators, controllers, and observers prior to, during or after the Exercise. This includes instructions, documents, and information provided at training sessions and/or meetings.

2. All communications or other documents concerning the scope, methodology or implementation of the Exercise, and the specific procedures to be performed or actually performed.

3. All documents and information concerning the Exercise or concerning roles, functions, duties, or events expected to occur during the Exercise that were provided by the NRC, or Applicants to federal evaluators, simulators, controllers, observers, or NRC personnel, or any other persons at any time prior to the Exercise.

4. All logs generated or maintained by each and every evaluator, controller, or observer, including NRC or Applicants, prior to, during or subsequent to the Exercise, including all appendices, comments, and summaries which are a part thereof.
5. All audio, video or other electronic recordings, or transcripts of recordings, of conversations involving NRC or Applicants' personnel concerning the Exercise.
6. All documents describing or pertaining to discussions or communications on the Exercise, and occurring before, during, and after the Exercise between or among NRC evaluators, controllers, and observers; NRC controllers and evaluators, or between NRC and Applicants' personnel.
7. All photographs of events occurring during the Exercise.
8. All reproductions of any "status boards" as they existed during the Exercise.
9. All time lines prepared by participants, evaluators, controllers, or observers of any events occurring during the Exercise.
10. All charts, graphs, maps, diagrams, drawings, or physical evidence pertaining to events which occurred during the Exercise.
11. Any and all documents which describe the purpose of the Exercise, or the NRC evaluation guidelines or process for the development of the Exercise.
12. All summaries, notes, logs, or other documents which reflect the observations and other matters that took place at any meeting(s) with the NRC or Applicants evaluators, controllers, and observers concerning the Exercise, regardless of meeting date.
13. All documents containing factual or evaluative information, prepared during or after the Exercise, by NRC or Applicants' participants, evaluators, controllers, or observers.
14. All other information, communications, or documents provided to federal evaluators after the Exercise to be used in developing their evaluations or reports.
15. All other documents, summaries, notes, logs, time lines, evaluations, comments, critiques, or reports concerning

the Exercise and prepared after the Exercise by federal or Applicants' participants, evaluators, controllers, or observers.

16. All documents, including minutes, transcripts, summaries, or notes, concerning any meetings at which NRC or Applicants' evaluations, critiques, or comments on the Exercise were discussed.

17. All correspondence, memoranda, or other records of communications between NRC personnel or between NRC and Applicants about drafts of documents or records on the Exercise.

18. All correspondence, memoranda, or other documents regarding the preparation and/or content of the Exercise, including any and all proposed versions and the final version, of the Exercise scenario, and any and all documents relating to any changes that were made to original version of the scenario in developing the final version.

19. For each document previously requested herein, produce all drafts of each document.

If, for any reason, you withhold any document or part thereof, please describe the material that is withheld, by title, date, author, and summary of content, and explain your reasons for believing it is exempt from disclosure under the Freedom of Information Act. In addition, please explain why the public interest does not require disclosure.

Please notify me of the copying and mailing costs for production.

I look forward to receiving your response within ten (10) working days, as provided in the Act.
