On August 15, 1980, notice was published providing an opportunity to comment upon the "Draft Programmatic Environmental Impact Statement related to decontamination and disposal of radioactive wastes resulting from March 28, 1979, accident at Three Mile Island Nuclear Station, Unit 2" (NUREG-0683), which was prepared by the Commission's Office of Nuclear Reactor Regulation. Comments on NUREG-0683 were requested to be submitted by October 6, 1980.

Pursuant to the National Environmental Policy Act and the U.S. Nuclear Regulatory Commission's regulations in 10 CFR Part 51, notice is hereby given that the comment period is being extended. Comments are now due by November 20, 1980.

Upon consideration of comments submitted with respect to the Draft Programmatic Environmental Impact State ent, the Commission's staff will prepare a Final Programmatic Environmental Impact Statement, the availability of which will be published in the Federal Register.
