2. DESCRIPTION OF AMENDMENT/MODIFICATION

Pursuant to Section J - SPECIAL PROVISIONS, Subsection J.4, RESPONSIBILITY AND LIABILITY FOR DAMAGE OR INJURY/INSURANCE of the contract, the purpose of this Supplemental Agreement is to increase the total amount of the contract by \$427.60. This will cover damage to the leased automobiles that occurred during the term of the contract. Therefore, the following changes are made to the contract:

I. Under Section K - CONTRACT ADMINISTRATION DATA, subsection K.2, OBLIGATION OF FUNDS AND COMPENSATION, delete a. and b. in their entirety and substitute the following in lieu thereof:

"a. The total cost to the government for the full performance of this contract during the period of performance is \$20,928.12.

b. The total funds currently obligated and available for payment under this contract is \$20,928.12. It is estimated that the amount currently obligated will cover the period of performance from the effective date of the contract through May 5, 1980, and all claims for damages submitted by the Contractor thereafter."

Except as provided herein, all terms and conditions of the document referenced in block 8, as heretofore changed, remain unchanged and in full force and effect.
