2. Any guidelines, manuals of procedure, or regulations prepared by the NRC to guide NRC personnel on the timing and/or mechanics of how NRC inspections are to be conducted, inspection reports prepared, and the like, including in particular documents which relate to standard or routine procedure for inspections and determining when inspections should be made.
