In response to the subject letter regarding our previous letter of April 10, 1980 concerning the subject inspection we offer the following responses:

Request for Additional Information - NRC Letter of June 28, 1980

Section 2.201 of the NRC's "Rules of Practice" Part 2, Title 10, Code of Federal Regulations requires that your reply include, among other things, the date when full compliance will be achieved. Your letter of April 10, 1980 did not include a specific statement in that regard concerning items A through C although in some cases a date could be inferred. In order to preclude misinterpretation and to comply with regulatory requirements, we request that you provide that information. We note that further reports are planned by you concerning item D.

Response to Request for Additional Information

Item A - Full compliance was achieved on April 4, 1980

Item B - As stated in our response of April 10, no corrective action was necessary regarding this item. Currently there are no subcontractors working on safety related equipment controlled in whole or part by the Bechtel Quality Assurance Program. However, effective April


10, 1980 any subcontracts written will clearly establish in writing the QA program responsibility if the subcontractor is to work in whole or part under the documented Bechtel Quality Assurance Program.
