Millstone Nuclear Power Station, Unit No. 1 STR Bundle Proprietary Information

Attached is NEDE-20592-5P, "STR Bundle Submittal, Millstone 1 Segmented Test Rod Bundle (Supplement 5)", dated June, 1980. This report is an Appendix to the Reload #7 License Amendment Submittal (Reference (1)). The Supplement updates the original report, submitter ctober 3, 1974, as part of the Reload #2 License Amendment Submittal; it was sep lemented in July, 1975; August, 1976; November, 1977; and April, 1979 (Revision 1), and describes proposed changes to be made in the bundle composition during the Fall, 1980 refueling outage. We have been informed by the General Electric Company that this information is considered proprietary by them for the following reasons.

These figures contain information which is of the type which General Electric customarily maintains in confidence and withholds from public disclosure. The information has been handled and classified proprietary by General Electric in accordance with the procedures and standards set forth in Attachment A to this letter, and we hereby make application for withholding from public disclosure this information in accordance with the provisions of 10CFR2.790. The analytical methods and the data which would be compromised by public disclosure of these figures were developed at considerable expense to the General Electric Company and the release of the information would allow competitors to confirm similar designs without incurring similar expense.

Northeast Nuclear Energy Company (NNECO) has proprietary agreements with the General Electric Company and has handled this information in accordance with those agreements.
