Subject: PROPOSED IMPOSITION OF CIVIL PENALTIES - \$2,000

This is to inform the Commission that a Notice of Violation and a Notice of Proposed Imposition of Civil Penalties in the amount of Two Thousand Dollars will be issued on or about September 25, 1980, to New England Nuclear Corporation. This action is based on alleged items of noncompliance relating to the delivery of byproduct waste material to a carrier for transport without affixing the proper labels as required by the regulations. A news release has been prepared and will be issued about the time the licensee receives the Notices. The Commonwealth of Massachusetts will be notified.

It should be noted that the licensee has not been specifically informed of the enforcement action. The schedule of issuance and notification is:
