Subject: PROPOSED IMPOSITION OF A CIVIL PENALTY - \$300

This is to inform the Commission that a Notice of Violation and a Notice of Proposed Imposition of a Civil Penalty in the amount of Three Hundred Dollars will be issued on or about September 25, 1980 to Michael Reese Hospital and Medical Center. This action is based on an alleged item of noncompliance relating to the licensee's procurement of xenon-133 gas from a supplier who did not distribute the material for human use in accordance with the Federal Food, Drug, and Cosmetic Act. The procured gas was administered by the licensee to patients for diagnostic studies. A news release has been prepared and will be issued about the time the licensee receives the Notices. The State of Illinois will be notified.

It should be noted that the licensee has not been specifically informed of the enforcement action. The schedule of issuance and notification is:
