Also attached is one signed copy of a Certificate of Service for License Change Application 65 to the chief executive of the county in which the facility is located and the Director of the State of Oregon, Department of Energy.

Appendix B to the Trojan Security Plan has been deleted as part of this Revision 5. Appendix B identified the 17 security modifications to be completed for compliance with 10 CFR 73.55 and the interim compensatory measures to be used while these modifications were being completed. As discussed in the August 18, 1980 letter from C. Goodwin, Jr. to R. H. Engelken, these modifications have been completed and the interim compensatory measures discontinued as of midnight on August 15, 1980.


