

LICENSE CHANGE APPLICATION

On Page 5 of the Trojan Nuclear Plant Facility Operating License (NPF-1), the last sentence of Section 2.D should be changed to read as follows:

"The approved security plan consists of documents withheld from public disclosure pursuant to 10 CFR 2.790(d) collectively titled 'Trojan Nuclear Plant Security Plan', Revision 5 dated September 1980".

Replacement pages to the Security Plan are provided as Attachment 4.

Changes are shown by vertical lines in the margins of Revision 5 replacement pages.

REASON FOR CHANGE

Portland General Electric Company (PGE) submitted Trojan Security Plan Revisions 4, 4a and 5 to the NRC and Oregon Department of Energy (ODOE) in March, May and July of 1979, respectively. Subsequent to those submittals, PGE was directed by the NRC to withdraw implementation of these revisions until an evaluation of the Trojan security program changes described therein could be evaluated. This withdrawal was effected on December 14, 1979.

NRC review comments on these withdrawn Revisions 4 and 5 were received by PGE in letters from A. Schwencer to C. Goodwin, Jr. dated October 22, 1979 and April 3, 1980. ODOE review comments on Revisions 3, 4, 4a and 5 were received in a letter from L. Frank to J. Williams of February 26, 1980.

PGE submitted draft responses to these NRC and ODOE comments in a letter from C. Goodwin, Jr. to Robert A. Clark dated June 13, 1980. A meeting of PGE representatives, Mr. Charles E. Gaskin of the NRC and Mr. William Dixon of ODOE, was held on August 4, 5 and 6, 1980 to discuss these draft responses and resolve conflicting PGE/NRC/ODOE issues and develop mutually acceptable responses to NRC and ODOE concerns.

Revision 5 amends the Plan as required to incorporate PGE's responses to the NRC and ODOE comments as mutually resolved in the August 4, 5 and 6, 1980 meeting. Three attachments to LCA 65 are provided to facilitate your review of Revision 5, namely:

- (1) Attachment 1 - provides PGE's responses to the NRC comments on withdrawn Revisions 4 and 5 dated March and July, 1979, respectively.
- (2) Attachment 2 - provides PGE's responses to the ODOE comments on the currently effective Revision 3 and on withdrawn Revisions 4, 4a and 5 dated March, May and July 1979, respectively.
- (3) Attachment 3 - provides a list of the changes, whether the changes degrade security and the basis for this determination, and, if so, the justification for accepting the changes.

SAFETY EVALUATION

This change has been determined to not constitute an unreviewed safety question. It is compatible with the overall Plant safety design and is in compliance with regulatory requirements. The margin of safety or probability or consequences of accidents analyzed in the Trojan Final Safety Analysis Report have not been changed. This change affects the physical security program of the Plant and does not involve changes to equipment, systems, procedures or administrative controls required for Plant operation.

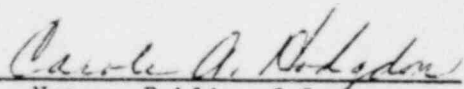
