Subject: INTERAGENCY AGREEMENT NO. NRC-02-80-069 Entitled,
"Evaluation of Locations and Rates of Ground-Water
Discharge From the Sheffield Low-Level Waste Disposal
Facility"

Pursuant to the Economy Act of 1932, the Nuclear Regulatory Commission (NRC) and the U.S. Department of the Interior Geological Survey (USGS) desire to enter into an agreement whereby USGS will assist the NRC by providing services for the project entitled above.

Accordingly, the terms and conditions of this interagency agreement are set forth below:

Article I - Statement of Work

The USGS will provide services to the NRC as set forth in the attached Statement of Work and as further amplified in the USGS proposal dated August 18, 1980, as amended and attached hereto.

Article II - Period of Performance

This agreement is effective September 30, 1980 and shall continue through September 30, 1982.

Article III - Estimate of Cost and Obligation of Funds

The estimated cost of the proposed effort and the amount presently obligated by NRC is \$185,586.00 (B&R No. 50-19-03-02; Fin No. B-6967-0). Submission of USGS vouchers for payment shall be in accordance with the attached Billing Instructions.

Article IV - Technical Direction


- (a) The NRC Project Officer, Gale Turi, is responsible for guiding the technical aspects of the project and for general surveillance of the work performed. The Project Officer is not authorized to

make any commitments or any changes which constitute work not within the general scope of this agreement, or constitute a basis for any increase in costs or extension of the Period of Performance.

- (b) ALL TECHNICAL DIRECTIONS SHALL BE ISSUED IN WRITING BY THE PROJECT OFFICER OR SHALL BE CONFIRMED BY HIM/HER IN WRITING WITHIN TEN (10) WORKING DAYS AFTER VERBAL ISSUANCE. A copy of said written direction shall be provided to the Contracting Officer.
- (c) In the event the Project Officer desires a change to the agreement, he/she must direct such request to the Contracting Officer. The Contracting Officer will handle the request in accordance with applicable laws and regulations.


