Election of several new corporate officers and reorganization of some areas of the Company, effective Oct. 1, have been announced by Robert H. Short, who becomes Chairman of the Board and Chief Executive Officer at that time.

Short succeeds Frank M. Warren who retires Oct. 1, after 43-years with the Company. Warren will continue to serve on PGE's Board of Directors.

The intent to elect Short to his new position and William J. Lindblad as President and Joseph L. Williams as Vice Chairman of the Board was announced at PGE's annual stockholders meeting in May. Williams has also been elected to PGE's Board of Directors.

Short announced today that James W. Durham, Ken L. Harrison and Charles L. Heinrich, all presently Vice Presidents, become Senior Vice Presidents.

Durham has responsibility for PGE's legal, public affairs and public relations activities. Financial, budget and administrative service functions report to Harrison while rates-resenue requirements, data services and human resource areas report to Heinrich.

Newly named as Vice Presidents are Charles Goodwin, Jr., Leslie E. Hodel, Donald R. Miller, E. Kay Stepp and Bart D. Withers.

Withers has responsibility for operation and engineering activities specifically related to PGE's nuclear projects. Goodwin is responsibile for operation and maintenance of other thermal power plants. Hodel is responsibile for engineering and construction activities of all other PGE projects.

Withers, Goodwin and Hodel report to Lindblad along with the corporate planning, thermal operations and internal audit areas.

In her new assignment, Stepp is responsible for human resources encompassing all of the manpower planning and development, labor relations, compensation and employment functions. She reports to Heinrich.

Miller has responsibility for corporate services including land, fleet management, purchasing and stores. He reports to Williams. The utility's division operations, ower operations and security department will also report to Williams.

In addition, Peggy Y. Cree has been named General Manager for Environmental Services. She reports to Williams.
