12. DESCRIPTION OF AMENDMENT/MODIFICATION

This Supplemental Agreement is issued to incorporate the contract effort for Fiscal Year 1981 (FY 1981).

A. Under Article I - Period of Performance, the date for expiration of this agreement is hereby extended to September 30, 1981.

B. Under Article II - Scope of Work, the following paragraph is added:

"FY 1981 Services:

The Department of Justice (DOJ) shall continue to provide access to the JURIS General Legal Data Base for FY 1981. The NRC will reimburse DOJ at rates to be mutually agreed upon by the parties and such rates shall be incorporated herein prior to expiration of FY 1981. Until such rates are incorporated herein, the NRC shall continue to reimburse DOJ for these services at the rates reflected in the "Memorandum of Understanding for JURIS Online Retrieval Services for Fiscal Year 1980" undated which was incorporated herein by Modification No. Six (6)."

Except as provided herein, all terms and conditions of the document referenced in block 8, as heretofore changed, remain unchanged and in full force and effect.
