In accordance with the Contracting Officer's Decision of February 19, 1980 and Ace Federal Reporters, Inc.'s proposal for reimbursement dated May 1, 1980, the parties agree to full and final settlement of the above matter for a total equitable adjustment of \$11,167.44.

Ace Federal Reporters, Inc., agrees that in consideration of the foregoing modification, it hereby for itself, its successors and assignees, remisses, releases and forever discharges the Government, its officers, agents, and employees, of and from all liabilities, obligations, claims and demands arising under or connected with this Contract NRC-17-77-117, the subject matter of which was in existence on or prior to the date of this modification (whether or not asserted by or known to the Contractor, and whether costs, losses, and expenses thereto were incurred prior to

Furnish an original (typed or mimeographed) of records of hearings (daily press briefings), on an "on call 24 hour basis" at Middletown, Pennsylvania, for the period beginning April 2, 1979 and ending May 7, 1979. In consideration of these services, the Contractor shall be paid a fixed amount of \$11,167.44.

2. This modification does not change the total amount obligated under this contract.
3. All other terms and conditions remain unchanged.
