Dear Mr. Nininger:

This is in reply to your letter to Dr. A. R. Matheson requesting current data on commercial purchases of natural uranium. Information requested is as follows:

1. Firm Uranium Concentrate Purchase Commitments

- a. Union Carbide - 1,000 tons in 1977. Option to delay 500 tons of 1977 quantity until 1978, exercisable by December 31, 1973.
- b. Ranchers Exploration & Development Corp./Houston Natural Gas - 500 tons per year, 1976 through 1985. 2,500 tons minimum total quantity, balance depending upon reserves.

c. Letters of intent to purchase

1. SCHIO Petroleum Co./Reserve Oil & Minerals

2. EXXON Nuclear Co.


