

Gentlemen:

This refers to the inspection conducted by Mr. Oberg of this office on April 30-May 2, 1974 of activities authorized by AEC License No. DPR-5 and to the discussions of our findings had by Mr. Oberg with Mr. Autio and others of your staff at the conclusion of the inspection, and to a subsequent telephone discussion between Mr. Autio and Mr. Oberg on May 3, 1974.

Areas examined during this inspection are described in the Regulatory Operations Inspection Report which is enclosed with this letter. Within those areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations or safety items were observed.

In accordance with Section 2.700 of the AEC's "Rules of Practice", Part 2, Rule 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the AEC's Public Document Room.
