Gentlemen:

This refers to the inspection conducted by Mr. Mann of this office on May 31, 1974 at Yankee (Rowe) Plant of activities authorized by AEC License No. DPR-3 and to the discussions of our findings held by Mr. Mann with Mr. Autio and Mr. Jones of your staff at the conclusion of the inspection.

The area examined during this inspection was limited to Health Physics Refueling Procedures. Within this area, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations or safety items were observed.

In accordance with Section 2.790 of the AEC's "Rules of Practice", Part.2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the AEC's Public Document Room. 
