Dear Mr. Ahearne:

The AIAA Society and Aerospace Technology Technical Committee is planning a broad multidiscipline workshop/conference between the aerospace and electrical power communities. We began our work and planning prior to TMI, believing the problems/needs within the electrical power area to be extremely important to our national interests and that aerospace technology could bring large benefits under an effective transfer framework. Since TMI, this effort has grown considerably in the understanding of its potential. Both available technology utilization and cooperative R&D between the electric power community and other high technology areas appear to be sound objectives.

Our committee has previously conducted a similar activity between the aerospace and maritime communities which was very successful and we believe it to be a good model for our present planning (a copy of the proceedings is enclosed to provide an understanding of the model approach). Also we addressed the overall cooperative concept, as well as, prospects for an aerospace/electrical power joint effort in a special AIAA session at the Global Technology 2000 meeting held in Baltimore, Maryland. Mr. Floyd W. Lewis gave an address during this program which provided considerable positive evaluation of this concept (a copy of the special program is attached).

We would like to meet with you for a 30-minute discussion. We would present a short briefing on (1) the Institute's goals for providing responsible/balanced assistance to the national decision making process through its broad technical membership and (2) specific information pertaining to the planned comprehensive workshop/conference.
